STRONG suspicion of black-box royalties

95/100

Strong suspicion of black-box royalties (score 95/100) — driven by multiple versions, metadata fragmentation, split isrc / ownership.

FINDINGS

Multiple versions	+25
3 distinct versions detected (explicit, radio edit, speed up). Royalties for each variant can land in separate, unmatched buckets.	
Metadata fragmentation	+20
12 differing artist/credit strings across rows — a classic cause of unmatched funds on big-label releases.	
Split ISRC / ownership	+16
19 distinct ISRCs for this recording — multiple masters/labels increase the odds of unmatched royalties.	
Name variations	+12
Claimant credited under 6 name forms (e.g. "gunna" vs "tony gunna"). Name mismatches block automated matching.	
Incomplete IPI linking	+12
No IPI present on the reviewed rows — performer cannot be reliably matched to accrued funds.	
Primary/lead credit	+10
Gunna is credited as a primary/lead artist — entitled to the full performer share (~45%), a stronger claim than featured-only.
